

LEGAL NOTICE

Pursuant to an Order Approving a Final Settlement of

Blackford, et al. v. At Home Corp., AT&T Corp., Case No. 416131, and *Bolyard v. AT&T Corp., AT&T Broadband LLC*, Case No. 416614, in the Superior Court of the State of California, County of San Mateo.

You May Be Eligible For a Voucher in the Amount of Fifty Dollars (\$50) or A Check in the Amount of Fifteen Dollars (\$15.00).

WHO'S ELIGIBLE: All California residents who subscribed to the TCI At Home cable internet service between March 12, 1997 and March 8, 1999, or the AT&T At Home cable internet access service between March 9, 1999 and September 29, 2001 (hereinafter "the Settlement Class").

WHAT ARE YOU ELIGIBLE FOR: What you are eligible for depends upon whether you are an existing customer of Comcast and what services you receive, as follows:

Members of the Settlement Class who are **Current Internet Subscribers** of Comcast and are also Current Video Subscribers of Comcast, and who submit a valid and timely Claim Form, will receive up to \$50 equivalent value in "Comcast Dollars" in the form of a voucher to be used by the Claimant for any combination of the following services offered by Comcast: video installation, premium installation, premium channel "a la carte" selections, pay-per-view movies, digital upgrades.

Members of the Settlement Class who are **Current Video Subscribers** of Comcast but are NOT also Current Internet Subscribers of Comcast, and who submit a valid and timely Claim Form, will receive up to \$50 equivalent value in "Comcast Dollars" in the form of a voucher to be used by the Claimant for either Comcast internet installation/service, or for any combination of the following services offered by Comcast: video installation, premium installation, premium channel "a la carte" selections, pay-per-view movies, digital upgrades.

Members of the Settlement Class who are NOT Current Video Subscribers of Comcast NOR Current Internet Subscribers of Comcast, and who submit a valid and timely Claim Form, will receive up to \$50 equivalent value in "Comcast Dollars" in the form of a voucher to be used by the Claimant for either Comcast internet installation/service or for any combination of the following services offered by Comcast: video installation, premium installation, premium channel "a la carte" selections, pay-per-view movies, digital upgrades. **Alternatively, Settlement Class members who no longer subscribe to either service can elect to receive \$15.00 cash IF proof of being a former customer is provided in the form of an invoice or other documentation of having subscribed to the AtHome internet service.**

HOW TO RECEIVE YOUR VOUCHER OR CHECK: Fill out the lower portion of this form and mail it back to the address shown below. You must affirm that you were a California resident who subscribed to the TCI At Home cable internet service between March 12, 1997 and March 8, 1999, or the AT&T At Home cable internet access service between March 9, 1999 and September 29, 2001. **All claims are subject to verification.** The form must be postmarked by November 27, 2004.

Comcast, at its discretion, may randomly check billing records to confirm that you were a subscriber.

You will receive the voucher or check by mail in approximately three to four weeks.

If it is determined that you are not eligible to receive the voucher or check, you will be so informed.

YOU MUST INCLUDE PROOF OF YOUR SUBSCRIPTION WITH THIS CLAIM FORM (E.G., A SERVICE BILL OR A CANCELLED CHECK REGARDING YOUR PRIOR TCI OR AT&T AT HOME ACCOUNT).
