As a courtesy, we have compiled the requirements for some areas that require an alarm registration/user permit on the reverse side of this letter. This list is not exhaustive and you should confirm registration requirements with your municipality.

**AS PER TAOSCOUNTYORDINANCE NO. 1996-8 IN ADDITION TO OTHER REMEDIES PROVIDED BY LAW AND THOS SET FORTH HEREIN, ANY PERSON WHO VIOLATES THE PROVISIONS OF THIS ACT, OR FAILS TO COMPLY WITH ANY OF ITS REQUIREMENTS, SHALL BE SUBJECT TO A LATE FEE OF TEN DOLLARS (\$10.00), LATE FEE SHALL BE DUE AND PAYABLE WITHOUT FURTHER DEMAND FROM THE COUNTY.**

**ANY PERSON PROPOSING TO ENGAGE OR ENGAGING IN BUSINESS WITHIN TAOS COUNTY (OUTSIDE OF THE FOUR MUNICIPALITIES OF TAOS COUNTY), SHALL APPLY FOR AND PAY A BUSINESS REGISTRATION FEE FOR EACH OUTLET, OR LOCATION WITHIN THE LIMITS OF TAOS COUNTY PRIOR TO ENGAGING IN BUSINESS.**
